

## ALT AZ "Cayman Jack Weekend Getaway" Sweepstakes Official Rules

**NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.**

1. **When to Enter:** The ALT AZ "Cayman Jack Weekend Getaway" Sweepstakes ("Sweepstakes") will run from Sept 5, 2022, at 12:00:00 AM Mountain Time ("MT"), through Oct 2, 2022 at 11:59:59 PM MT ("Sweepstakes Period").

2. **How to Enter:** There are two (2) ways to enter:

**i) ALT AZ App:** To enter, you must download the ALT AZ mobile Stream Player app (the "App") from your App marketplace to your iPhone, iPad, or Android device, and open the App on your smartphone or iPad or tablet. Upon opening the App, you must register to be an App Rewards Member by visiting the Sponsor's website at [www.ALTAZ933.com](http://www.ALTAZ933.com). Once you become an App Rewards Member, each weekday during the Sweepstakes Period, listen to ALT AZ through the ALT AZ App for 8 hours or more each day to automatically receive one (1) entry into the random drawing. Please note: you must be registered through the App to be eligible to enter. Limit of one (1) entry per person per day regardless of the amount of daily listening over 8 hours. All entries must be received by 11:59:59 PM MT on August 28<sup>th</sup>, 2022 to be entered into the random drawing. Sponsor is not responsible for lost, late, delayed, incomplete listening hours.

**ii) Text Keyword:** To enter via this method of entry, text the keyword **CAYMAN** (Keyword) during the Sweepstakes Period to **28082**. Upon texting the correct Keyword, you will automatically receive one (1) entry into the random drawing (a "Text Entry" or "Entry"). All Text Entries must be received by 11:59:59 PM MT on the Oct 2, 2022 to be entered into the random drawing. Any entry that doesn't contain the correct Keyword, or that is sent after 11:59:59 PM MT on Oct 2, 2022 will be disqualified and will not be eligible for the random drawing. Text message and data rates may apply. In the event of a dispute regarding the identity of the person submitting a mobile text entry, the entry will be deemed to be submitted by the person in whose name the mobile number is registered. The entrant may be required to provide evidence that the entrant is the authorized account holder of the mobile number associated with the winning entry and complete an affidavit and any applicable release. Sponsor will notify the potential Grand Prize winner by telephone or email and will make up to **two (2) attempts** to reach the potential winner.
